背景:

对于在 SEC1 和/或 SEC2 上安装了 SEC C 计算机(软件标准为 122, 12 4 或 125)的飞机,在发动机起动时,电源转换过程中可能出现 "SEC OR WIRI NG FROM L or R ELEV POS MON XDCR"和/或 "SEC OR WIRING FROM G or Y ELEV POS XDCR"故障信息。在对 SEC C 计算机软件标准升级到 126 之前,需对 AFM 作临时修订,加入发动机启动后重置 SEC1 和 SEC2 的要求。

之前根据 EASA AD No.: 2015-0191R0 要求,已下发 MEM02015-005R0 通知飞行技术管理部对受影响飞机的 AFM 临时插页。因为后续发布的 EASA AD No.: 2015-0191R0 Correction,修订了 AFM 临时插页的版本号和批准日期,CAD 2015-A320-08R0 的要求与 EASA AD No.: 2015-0191R0 Correction相同,故此下发本 TA 替代 MEM02015-005R0。

R1 版:根据 SB A320-27-1252,我司还有未交付的飞机的 SEC C 计算机还未升级到 126,R1 版修订了有效性,将这些受影响的飞机列入到本 TA 适用性中。故改版 TA 到 R1 版通知飞行管理部确认这些飞机的 AFM 已经插入临时修订AFM A320 TR572 issue 1的插页。

R2 版: 因机队中 B9986 B9965 B8248 B8247 B8012 B8000 B1896 B189 5 B1893 B1892 B1840 B1839 B1807 B1672 B1671 B1670 B1657 B1656 B1628 B 1627 飞机已完成 SB A320-27-1252 所要求的 SEC C 计算机升级到 126 版本的改装,在适用性中删除这些飞机并修订正文,要求取消这些飞机的 AFM 临时修订。MSN6870 飞机不再引进,故从有效性中删除该飞机,有效性中增加 MSN 对应的飞机注册号。

R3 版: 因为 EASA AD 2016-0056 替代了 EASA AD 2015-0191, CAD2015-A320-08R0 已改版到 R1,修订标题和参考文件,修订正文(1)部分。

因 SB A320-27-1252R0 已改版到 R1 后要求确认 SEC C 计算机已升级到 126 版本的飞机的 0EB 50 已取消,修订正文增加注释。

按质量管理处要求,完成适航指令的情况需反馈,附件中增加《适航指令执行情况反馈单》。

根据 MSCN CQH27D9401021M3B Iuuse3, B-8370 (MSN6815) 、 B-8371 (MSN 6826) 、B-8327 (MSN6846) 、B-8427 (MSN6858) 、B-8346 (MSN6874) 、B-8347 (MSN6 881) 这几架飞机已计划在生产线上执行 MOD161208 改装,将 SEC C 升级到软件版本 126,修订正文(2)部分。

For the aircraft equipped with SEC C standard 122,124 or 125 on SEC 1 or SEC 2, the messages "SEC OR WIRING FROM L or R ELEV POS MON XDCR" and/or "SEC OR WIRING FROM G or Y ELEV POS XDCR" will be triggered due to power transisents, when the engines are started. The AFM amendment should be accomplished to reset the SEC1 and SEC2 after both engines starting. It is expected that SEC C standard 126 will be the final solution.

According to EASA AD No.: 2015-0191RO, MEMO2015-005RO has be en issued before to notify Flight Technology Management Dept to amend

the AFM of the applicable aircrafts. According to EASA AD No.: 2015-0191RO Correction, AFM TR references and approval data have been corrected, and the requirement of CAD2015-A320-08RO is the same as that of EASA AD No.: 2015-0191RO Correction, so this TA issued to supersede MEM02015-005RO.

R1 revision: According to SB A320-27-1252, there are some air crafts, which have not been delivered, equipping with SEC C software before 126. R1 revised the applicability of TA to add these aircraft s.R1 revision notify Flight Technology Management Dept to make sure these aircrafts AFM has been inserted AFM A320 TR572 issue 1.

R2 revision: For the aircrafts B9986 B9965 B8248 B8247 B8012 B8000 B1896 B1895 B1893 B1892 B1840 B1839 B1807 B1672 B1671 B1670 B16 57 B1656 B1628 B1627 have updated SEC C software 126 in accordance with SB A320-27-1252, these aircrafts were deleted from effectivity column and the text was revised to cancel the AFM amendment. For MSN6870 will not be deliveried, so it was deleted from effectivity column. A dded the aircraft register number related with MSN.

R3 Revision: Because EASA AD 2016-0056 superseded EASA AD 2015-0191, CAD2015-A320-08R0 revised to R1, TA title, text (1), reference document were revised

SB A320-27-1252RO revised to R1 to make sure that OEB 50 of the aircrafts equipping with SEC C have been cancelled after SEC C updated to software 126, text was revised to add NOTE.

The result after CAD completed should be fed back in accordance with the requirement of Quality Management Office, attachment was revised to add 《CAD execution feedback form》.

According to CQH27D9401021M3B Iuuse3, B-8370(MSN6815), B-8371(MSN6826), B-8327(MSN6846), B-8427(MSN6858), B-8346(MSN6874), B-8347(MSN6881) are scheduled to embody MOD 161208, updating SEC C software standard 126, text(2) was revised.
